

**MONTHLY ESCROW AGREEMENT WITH COUPONS**

The taxpayer hereby requests the Wood County Treasurer to accept prepayments towards the estimated real property taxes, next due after the date of signing this agreement, and that pre-payment will be retained in an escrow account until the next current tax collection is open and all prepayments can be applied toward the payment of real estate property taxes then due.

The taxpayer authorizes the Wood County Treasurer to act as agent for the purposes of receiving the tax bill(s), and applying the prepayment to the real estate taxes then due.

The Treasurer agrees to retain all prepayments in an escrow account, receive and pay the bill(s), and provide the taxpayer on request with a summary of the account that includes all prepayments, tax payments and the balance in the escrow account.

The Treasurer agrees to furnish a tax bill that shows the total amount of prepayments made and the balance due at least 20 days prior to the closing date of the collection then in progress.

Monies received as prepayments in the escrow account will not be released for other than the payment of taxes, except for reasons pertaining to transfer of ownership, death of taxpayer, or as required by law. Excesses remaining in an escrow account after the payment of real estate taxes will (1) remain and be applied toward future real estate taxes, or (2) be returned to the taxpayer upon application to the County Treasurer. The application for return of excess escrowed funds will automatically terminate the existing agreement.

For the purposes of this agreement, the County Auditor's conveyance of real property transfer record shall control in matters of ownership and transfer. In the event of death, a death certificate shall be required. In all other matters, Section 321.45 of the Ohio Revised Code shall apply.
